SENIOR SCHOLARSHIP ELIGIBILITY REQUIREMENTS

This scholarship is for any graduating senior who is furthering their education by attending a university, college, community college, technical school, culinary or fine arts academy.

The scholarship criteria is explained below:

- One (1) scholarship will be given to each of the RRISD high schools and SUCCESS in the amount of \$500.
- Student must be a current PTSA member of their home campus.
- Student must not have any major referrals.
- Student must show evidence of community service, leadership, school involvement and PTSA involvement.
- Student will be asked to write a short essay in which they are asked to “Describe your contribution to your PTSA. How has that made a difference in your life or a difference in your school/community?”
- Scholarship application deadline is the Friday after Spring Break.

FYI = A rubric will be used to “evaluate” each applicant. Each scholarship committee member must fill out a separate rubric for each applicant.
